In fact, **the Group manages and maintains the data on its servers exclusively in Italy, which are in no way connected to the institutional site.** This is because **Olidata makes cybersecurity one of its main businesses**, has several years of experience in the field and today is **one of the leading companies in this market in our country.**

Numerous institutions and large economic and financial players are turning to Olidata experts to deal with growing cyber threats. The company is constantly investing in the development of new proprietary technologies capable of anticipating attacks, preventing intrusions and, if necessary, dealing with them in a timely manner. Worth mentioning is the latest solution designed precisely to network among the main Italian strategic players, **The Oli One: capable of monitoring h24 the network** (including deep and dark web), **intercepting the threat in just 25 seconds**, blocking the intrusion and sending an alert not only
